Happy new year, VFW! As we continue growth, Commander-in-Chief Al Lipphardt has instituted a monthly Commander's Challenge. As a reminder, every month we will award points to our Posts as follows:

- Recruit a New Annual Member into the Post: 1 point

- Recruit a New Life Member into the Post: 10 points

Military Assistance Program (MAP) Grant Funds

Be advised that the VFW MAP Grant is now closed for the 2024-25 program year. The 2024-25 MAP Grant funds have been depleted. Any events held after the closure of the MAP grant will not be reimbursed with the 2025-26 funds.

All American Eligibility

To qualify for **All-American**, a **minimum donation of \$125** must be donated to **VMS** by **June 30, 2025**. VMS donations will only be handled through the Dashboard. All Posts must click on the “**VMS Donation**” tab on the **Dashboard** to donate. The link will point them to OMS. Please do not send checks to the National Headquarters. If a Post does not use a credit card, the Post will send their donation to their Department HQs and the Department HQs will submit the donation for their Post. Credit will automatically update on the Dashboard daily. Overseas Departments will donate to the other programs through the link also in lieu of participation. This will automatically update daily.

When you make your **\$125.00** or more donation, all that needs to be entered into the box is 125 or more. The **\$** and **.00** are **not required** in the donation amount box.

Do not use the red donate link in the upper right-hand corner of this webpage. This is for general donation purposes only.

DISPLAYING MILITARY SERVICE SYMBOLS. Military service flags, insignias, etc. should be displayed in the following order (left to right as you face the flags): Army, Marine Corps, Navy, Air Force, Space Force and then Coast Guard. For military flags, go to vfwstore.org/searchresults?q=MilitaryFlag.

VFW 125TH ANNIVERSARY COMMEMORATIVE POST PROGRAM SIGN UP. We encourage as many of our VFW posts to get signed up to become a 125th Anniversary community service Post. To date, we have 89. Please help us spread the word. Our birthday was a couple of days ago, but our celebration will last the rest of the year and conclude at the National Convention in Columbus.

The VFW National Commander invites all VFW Posts to be the catalyst to get their communities involved in commemorating the contributions of all veterans and their family members to our country during the VFW 125th Anniversary year. In addition, it is hoped you will encourage your community to study the history of this era to help ensure a safer and better tomorrow.

PROGRAMS DASHBOARD TOOL. (NOTE: Previously ALL-AMERICAN DASHBOARD) Please encourage Posts to read the 2024-25 Membership program. Military Assistance Program grants have been launched to show Departments and Posts how much in grant assistance has been received from National HQs to supplement the Unmet Needs financial grants & VFW Sport Clips Help a Hero Scholarship statistics. FLY THE FLAG ON MARTIN LUTHER KING, JR.'S BIRTHDAY. The U.S. federal flag code has been amended by Congress and signed by the president to add Martin Luther King, Jr. Day to the list of days on which the flag should be displayed. His birthday is observed on the third Monday in January; therefore, the flag should be flown on that day. To purchase a U.S. flag from the VFW Store, go to vfwstore.org/category/flags/usflags.

Many communities are conducting community service projects that day. It is highly suggested that all members support this day of service.

SMART/MAHER VFW NATIONAL CITIZENSHIP EDUCATION TEACHER AWARD PROGRAM DEADLINE REMINDER. Nominations for this award and the judging at Post and District level, if applicable, should be completed at this time and their winners submitted to their VFW Department Headquarters for their judging by Jan. 1.

A completed nomination should consist of a completed official entry form with a one-page resume as a minimum or up to five-pages, including the resume, as a maximum of documentation of their teaching experience, (for example: resume, references, news articles, etc.) and a head-and-shoulder photo of themselves, if available at the time.

The corresponding deadlines for the next level of judging are as follows: Dec. 15, 2024, for completion of District judging, if applicable, and their winners forwarded to their Department Headquarters prior to Jan. 1, 2025; and Feb. 1, 2025, for completion of Department judging and their winners forwarded to National Headquarter. Each level may submit one candidate, in each grade category, on to the next level.

NOTE: The VFW National Programs Department requires the Department Headquarters to submit their winners via Formstack, using the link the Department Adjutants/Quartermasters recently received. For each Department winner, they will need to complete a “VFW Department Teacher Award Citation Request Form” located on Formstack, then download the winners’ entry documentation. VOICE OF DEMOCRACY AND PATRIOT’S PEN DEPARTMENT DEADLINE REMINDER. The deadline for submitting the Voice of Democracy and Patriot’s Pen winner packets to National Headquarters is Jan. 15, 2025 (even if they have not been personally notified, they are the winner).

The suggested deadline for Departments to have reviewed and approved their District and Post entries in the All-American Dashboard is Jan. 31. This will ensure we have accurate reporting numbers across the organization and allot us the time to remedy errors. If you are unsure how to report your participation in the All-American Dashboard or if you are having login issues to the OMS system, contact John Linstra at jlinstra@vfw.org or 816.968.2787.

VOICE OF DEMOCRACY AND PATRIOT’S PEN NATIONAL AWARDS. Every Voice of Democracy and Patriot’s Pen first place Department winner will receive a National scholarship or award. The amount for the Voice of Democracy National Awards now totals \$172,000, with the top three awards raised to \$35,000, \$21,000 and \$15,000. The Patriot’s Pen National Awards total is \$55,000.

VFW NATIONAL PUBLIC SERVANT AWARDS. Judging at Post level should have been completed at this time or the near future. VFW Post Safety Chairperson’s may submit up to five winning nominees’ documentation (one for each career area) to their Department Headquarters for judging no later than Jan. 1.

Once judging has been completed, Departments may submit their five winning nominees, if available, (one for each career area) to the VFW Programs office, by completing the “VFW Department Public Servant Award Request Form” through Formstack. VFW Programs staff has emailed the form link to Department Adjutants/Quartermasters prior to the deadline of Feb. 1.

VFW Programs will create citations for the following awards in each Department:

- VFW National Law Enforcement Award
- VFW National Firefighter Award
- VFW National Emergency Medical Technician Award
- VFW National 911 Dispatcher Award
- VFW National Explosive Ordnance Disposal Technician (E.O.D.T.) Award

Each Department will receive their requested awards and should contact their recipients to arrange a presentation. Department Commanders may present the awards at their Department Convention, but are encouraged to also present the award in front of the recipient's peers at a professional association event, city council meeting, etc. The purpose of the second venue is to expose these VFW awards to the public and especially other law enforcement personnel, firefighters, EMTs, dispatchers and EODTs personnel, many of whom are veterans eligible for VFW membership. PLEASE REVIEW UPDATE ON O.C.S.P. PROGRAM. VFW National Programs has updated Outstanding Community Service Post award programs starting this program year. Please share this with your Community Service Chairpersons.

OUTSTANDING NATIONAL COMMUNITY SERVICE AWARD. Each year on July 1, the national Programs office will determine the top community service Posts in each conference, based off their community service reporting and total impact, from July 1 to June 30 the previous year. Your community service total impact is figured by the money spent to host and organize the community service event, plus total hours all volunteers participated, plus the mileage for all volunteers (Dollars Donated + Hours + Mileage = Total Impact).

These four Posts will be awarded the Award for Community Service and will be invited to attend the VFW National Convention. The Post Commander (or designated representative) and a guest will receive round-trip airfare, hotel accommodations for five nights, and a \$599 stipend to receive the award at the VFW National Convention.

NATIONAL COMMUNITY SERVICE POST OF THE YEAR. Each Department will have an NCSP winner based on total impact also. National will select based on end of year reports on July 1. Winners will also be published in the Convention program booklet and receive a street sign identifying this national award for the Post to put up in their community.

“UPDATED” POW/MIA FLAG -- OFFICIAL DISPLAY DAYS. Under previous Public Law 105-85 (Nov. 16, 1997), it indicated there were only six days that federal agencies, military installations and U.S. post offices were required to display the POW/MIA flag. Now under new law, Public Law 116-67 (Nov. 7, 2019), it is required that the POW/MIA flag, on certain federal properties, be flown on all days on which the flag of the United States is displayed. IRS AND VFW AWARD MONIES. The Internal Revenue Service (IRS) requires that any recipient that receives more than a \$599 award should receive a Form 1099 identifying the proceeds as taxable. This will include the VFW programs Patriot's Pen and Smart/Maher VFW National Citizenship Education Teacher Award.

"Buddy"[®] Poppy

"BUDDY"[®] POPPY CAMPAIGN. Although we emphasize Buddy Poppies on Veterans Day and Memorial Day, it is important to realize that the distribution of Buddy Poppies should be a year-round exercise. Each time a Post participates in an activity where the public will be present, Buddy Poppies should be present as a fundraising tool and simply to recognize our fallen comrades. Where the VFW appears, Buddy Poppies should be a constant reminder that we will never forget those who have perished in the name of liberty. Just as "They Gave, Will You?" is a year-round thing, so should the distribution of VFW Buddy Poppies.

Remember that your poppies should be ordered a minimum of three (3) weeks in advance of your distribution date.

BUDDY POPPY POLICY AND PROCEDURES:

- 1) Departments must order poppies through OMS.
- 2) All claims of non-receipt of a Buddy Poppy order must be made within 60 days of the date of the order or will NOT be replaced free of charge.
- 3) All orders for the traditional Buddy Poppy, Anniversary Poppies or tin tab poppies must be placed through your Department Headquarters. Auxiliaries must go through their Post to order all poppies.
- 4) The tin tabs do count towards the Buddy Poppy requirement for the All-American program.

- 5) If you do not receive your order within four weeks of placing it with your department, please contact your Department Headquarters to report you have not received your order.
- 6) All poppies are shipped within 10 days of ordering except orders placed in June and July, due to preparation for National Convention, please allow an additional five business days.

Miscellaneous items (coin cans, buttons, posters, etc.) should be ordered directly from the VFW Store at vfwstore.org/category/programs/buddypoppy or by calling Member Service Center at 1.833.839.8387.

The Manual of Procedure provides that Post relief funds may be used for programs such as Voice of Democracy, Patriot's Pen, Citizenship Education, and Community Service as long as suggestions in the chairperson's guidebooks are used as an example of promoting these programs.

Posts are further reminded that Section 711 of the Manual of Procedure provides that non-profit organizations, exempt from taxes under Section 501(a) of the Internal Revenue Code, may assist with the distribution of Buddy Poppies, provided there shall be no division of proceeds. A donation to these groups may be made from the Post general fund.

VFW ANNIVERSARY BUDDY POPPIES. Special poppies are available to Posts celebrating their 25th, 50th, 75th and 100th anniversaries. The poppies are the same design as traditional poppies but come in silver for the 25th anniversary Post, gold for the 50th anniversary Post and diamond (iridescent white) for the 75th anniversary Post. Posts currently in their 100th anniversary year can order any color and as many as they need. If not in your 100th anniversary year, please limit your order of anniversary poppies to 1,000 to ensure stock does not run out. These are ordered through the Department in OMS and processed the same as red poppies and should be distributed and used in displays just like the red poppies. Currently we have no plans to replenish inventory of Anniversary poppies due to increased cost and the small quantities we sell of Anniversary Poppies. Based on the past four years' sales, we have sufficient inventory for the next 2 years of the Gold, 3 years of Diamond and 50 years of the Silver.

National Veterans Service

New Accredited Representative Virtual Basic Training

NVS is excited to announce that Virtual Basic Accredited Representative Training will be available Feb. 3-7, 2025, for newly accredited representatives who have not yet participated in an NVS training conference. This conference will be a hybrid conference, with attendees receiving video training using the VFW Online Learning Portal as well as daily live instruction using Zoom teleconferencing software. Formal notification to students who are required to participate in this conference will be sent in the coming weeks, along with instructions on how to register and access the course.

National Legislative Service/Action Corps

VFW Hosts Veterans Justice Commission

The VFW Washington, D.C., office hosted the Veterans Justice Commission to discuss the work it does to examine the extent and nature of veteran involvement in the criminal justice system, and to develop recommendations for evidence-based policy changes that can enhance safety, health, and judicial fairness.

VFW National Legislative Director Pat Murray moderated a panel presentation with former Secretary of Defense Chuck Hagel and Commission Director Jim Seward during which they presented both state and federal policy proposals.

VFW Speaks at Women Veteran Caucus Event on Transition

VFW National Legislative Deputy Director Kristina Keenan spoke at the final event of the Servicewomen and Women Veterans Caucus of the 118th Congress, led by Reps. Chrissy Houlahan, Jen Kiggans, Derrick Van Orden, and Brad Wenstrup, all of whom are veterans. The discussion centered around the unique challenges that women face when transitioning out of the military such as service-connected injuries that affect fertility, mental health effects of military sexual trauma, and barriers to accessing benefits due to childcare constraints. Keenan explained that it is critical that all transitioning service members have access to a service officer to file their pre-discharge VA disability claims. "We know that veterans are vulnerable to suicide during the first year after separation from the military. We also know that veterans who use their VA benefits and health care have a lower risk of suicide. General Orders No. 6

2024-25 Series

1. Commanders at all levels should begin organizing their 2025 Memorial Day “Buddy”[®] Poppy Campaign. Every Post is urged to order and distribute VFW “Buddy” Poppies.
2. Attention is directed to Section 213 of the National Bylaws concerning any Post in arrears for any financial obligations to County Council (if applicable), District, Department and National for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured in accordance with Section 709, failing to submit properly completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year, or other obligations, shall be deprived of all representation in County Council and District meetings; County Council, District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.
3. Trustees shall not be eligible to serve as an elected officer, Adjutant or on a committee whose books, records and accounts are audited by the Trustees. Among the duties of the three (3) elected Post Trustees, they shall:
 - a. At least monthly, review the Monthly Report of Receipts and Expenditures of the Post Quartermaster.
 - b. Within thirty (30) days from the end of each quarter, properly audit the books and records of the Post Quartermaster, Post Adjutant and any activity, clubroom, holding company or unit sponsored, conducted or operated by, for or on behalf of the Post and submit a Post Trustee’s Report of Audit to the Department Quartermaster for referral to the Department Inspector.
 - c. The Report shall be in accordance with and upon such form as may be prescribed by the Adjutant General. The audit shall be signed by the Post Commander and Trustees, who shall, by their signatures, certify the accuracy of the information contained therein.
 - d. Perform such other duties as may be incident to the office or may from time to time be required by the laws and usages of the organization or lawful orders from proper authority.
