# DPA District 5 2024-25 Upgrade Raffle



District 5's goal during the current Term is to increase awareness among our members of the benefits of upgrading their membership to Life or Legacy Life.

To that end, District 5 will conduct an Upgrade Raffle during the 2024-25 Term.

The winning ticket will be drawn during the D-5 Convention in May 2025.

#### Raffle Rules:

- 1. Two categories of chances are offered.
  - a. \$10 chances are offered to Annual and Life members.
    - i. \$10 for one chance, six for \$50, or thirteen for \$100
    - ii. If an Annual member's \$10 ticket wins, he will be upgraded to Life.
      - This upgrade is a \$170 to \$425 value, depending on age.
    - If a Life member's \$10 ticket wins, he will be upgraded to Legacy Bronze, Silver, or Gold as appropriate.
      - 1. This upgrade is a \$400 value.
  - b. \$20 chances are offered to Annual members.
    - \$20 for one chance, four for \$60, or eight for \$120
    - If an Annual member's \$20 ticket wins, he will be upgraded to Life and then to Legacy Bronze.
      - The two upgrades represent a value of \$570 to \$825, depending on the winner's age.
- 2. Only one ticket will be drawn.
- 3. The winner will be upgraded at District Five's expense.
- 4. Each Post will set sales prices for the two categories of ticket sales in their local currency.
- The Post QM will transfer \$10 or \$20 (USD) (as appropriate) for chances sold to D-5's NFCU account.
- 6. Posts will e-mail D-5 QM Mark with names of Comrades that bought chances.

- 7. The winner will be drawn at the May 2025 District Convention in Chiang Mai.
- The winner does not need to be present to win.
- After the winning ticket is drawn at the May Convention, the winner's Post will upgrade the winner as appropriate.
  - Upon confirmation that the winner has been upgraded, D-5 will transfer the upgrade cost to the winner's Post.
